APPENDICES

NOTES TO APPENDICES AND DATA

All data for participants in this Report and in all appendices are from the Board's Campaign Finance Information System ("CFIS") as of March 11, 1992, with the exception of Appendices F (Loans) and G (Public Funds Payments), which have been updated to include data as of May 28, 1992. The CFIS database is, however, subject to change as a result of ongoing audits and additional filings received by candidates.

All appendices and analyses are limited to candidates on the ballot for the 1991 Council elections unless otherwise noted. Data for participants are from CFIS. Data for non-participants are from the September 23, 1991 and December 2, 1991 financial disclosure statements (or the most recent preceding filing, if these could not be obtained) for the primary and general elections, respectively, available at the City Board of Elections as of February 3-5, 1992. Vote totals for all candidates are as provided by the City Board of Elections.

Data in the Appendices

With the exception of Appendix A (The 256 Campaign Finance Board Participants in 1991), all appendices show only candidates on the ballot in either the primary or general elections. All appendices except B and C (1991 Primary Election Summary and 1991 General Election Summary, respectively) display data for participating candidates only. Unless otherwise noted, data in the appendices and the report do not include funds available from past elections (see Appendix D).

Appendix A: The 256 Campaign Finance Board Participants in 1991. This report lists all participants who joined the Campaign Finance Program for the 1991 City Council Elections. An asterisk denotes participants who made it onto the ballot in either the primary or general elections.

Appendix B: 1991 Primary Election Summary. This gives an overview of campaign finance in each district during the 1991 primary election, showing total contributions, public funds, spending, and the votes for each candidate.

Information Sources. All data for participants are from CFIS. Data for non-participants are from the September 23, 1991 (10-day post-primary) financial disclosure statement (or the most recent preceding disclosure statement, if this could not be obtained) available at the City Board of Elections as of February 3-5, 1992. Due to missing filings and irregularities in the reporting of financial data to the Board of Elections, the data shown may under-report the actual contribution and spending activity of non-participants in some cases.

Appendices

For purposes of accurate comparison with non-participant data, in this appendix, data for participants include financial activity reported to the Campaign Finance Board on or before September 18, 1991 (the reporting cutoff for the 10-day post-primary report), and outstanding bills are not included in participants' total expenditures. For these reasons, the data shown in this appendix for those participants in the primary election alone may not be equivalent to contribution and spending totals shown elsewhere in the report.

"Contributions" represents the sum of itemized and unitemized monetary and in-kind contributions, less contribution refunds and returned checks. Contribution totals do not include loans, transfers, or other receipts (such as interest), all of which may substantially increase the overall funds available to a campaign. "Gross CFB Payments" shows all public funds paid to a participant for the primary (and rerun elections, where applicable); monies returned to the public fund are not subtracted from this total. "Expenditures" shows itemized expenditure payments less any expenditure refunds (for example, refunds of telephone or rental deposits). (For participants, any expenditures reported as having been made in 1990 are reflected in the total for the primary.)

Contributions and spending for rerun elections were not distinguished from those for the primary election; as a result, contribution and spending totals for rerun elections are blank. Payments were made to some candidates for rerun elections that were later canceled. These payments are not reflected in this appendix.

Appendix C: 1991 General Election Summary. This gives an overview of campaign finance in each district during the 1991 general election, showing total contributions, public funds, spending, and the votes for each candidate.

Information Sources. All data for participants are from CFIS. For participating candidates who were also on the ballot for the primary election, the data represent financial activity occurring after September 18, 1991. For participating candidates in the general election only, the data represent all financial activity reported by that candidate. Data for non-participants were from the December 2, 1991 (27-day post-general election) financial disclosure statement (or the most recent preceding disclosure statement, if this could not be obtained) available at the City Board of Elections as of February 3-5, 1992. For those non-participating candidates who were also on the ballot for the primary election, contributions and spending were calculated by subtracting totals for the primary from cumulative totals shown on the 27-day post-general election report.¹ For non-participating candidates in the general election only, data displayed represent cumulative totals listed on the 27-day post-general election report. Due to missing filings and irregularities in the reporting of financial data to the Board of Elections, the data shown may under-report the actual contribution and spending activity of non-participants in some cases.

"Contributions" represents the sum of itemized and unitemized monetary and in-kind contributions, less contribution refunds and returned checks. Contribution totals do not include loans, transfers, or other receipts (such as interest), all of which may substantially increase the overall funds available to a campaign. "Gross CFB Payments" shows all public

funds paid to a participant for the general election; monies returned to the public fund are not subtracted from this total. "Expenditures" shows itemized expenditure payments and outstanding bills, less any expenditure refunds (for example, refunds of telephone or rental deposits). (For participants, any expenditures reported as having been made in 1990 by candidates not in the primary election are reflected in the total for the general election.)

Appendix D: Contributions and Other Receipts. This report shows monetary receipts, excluding loans. "Itemized Contributions" represents total itemized monetary and in-kind contributions received by each campaign. "Unitemized Contributions" shows total unitemized contributions received by each campaign (candidates are not required to itemize contributions of \$99 or less). "Refunds" shows the total amount of returned checks or contribution refunds for each campaign. "Total Contributions" includes itemized and unitemized contributions, less refunds. "Other Receipts" shows total income derived from sources other than contributions or loans (such as interest and proceeds from sales or leases), but does not include public funds payments. (For a complete record of public funds payments to candidates, see Appendix G). "Funds Available from Past Elections" shows funds deemed by the Campaign Finance Board to be left over from a candidate's previous election (if any), which is the opening balance of a committee the candidate authorized for the 1991 Council elections. "Total" includes itemized and unitemized contributions (less refunds), plus other receipts and funds available from past elections for each candidate.

Appendix E: Types of Contributors. This report shows total itemized monetary and in-kind contributions to participants from different types of contributors: "Individuals," "Corporations and Businesses," "Employee Organizations" (such as unions or guilds), "Political Committees" (including candidates' committees, PACs, and political party committees), and "Partnerships." The category of "Other Organizations" denotes contributions reported by campaigns that were not assigned to one of these five categories. Contribution refunds and returned checks are not subtracted. The types of organizations are identified based on codes assigned to contributors by the campaigns.²

Appendix F: Loans. This appendix shows total loans made to participating candidates and the number of lenders. "Total Loans" shows the total dollar amount of loans received by a participant. "Total Outstanding" is equal to total loans less any repayments and loans that were forgiven by the lender. Data in this appendix are as of May 28, 1992.

Appendix G: Public Funds Payments. This appendix describes public funds payments made to participating candidates for the primary and general elections, as well as any payments made in rerun elections.³ (Some rerun elections that had been scheduled were canceled. Participants in those districts were allowed to keep public fund payments made for these elections since they had made expenditures in anticipation of the elections. These payments are indicated by note 5 in the appendix.) "Gross Payments" includes all public funds payments to a candidate. "Returned Monies" shows any monies the candidate paid back to the Fund, which may include any of the following: surplus public funds, overpayments, and fines. "Net Payment" subtracts returned monies from gross payments. Data in this appendix are as of May 28, 1992.

Appendices

Appendix H: Expenditures. This report shows total itemized and unitemized expenditures made by each campaign during the 1991 elections, including outstanding bills, less any expenditure refunds (such as refunds of telephone or rental deposits). There are two broad categories of expenditures, "exempt" and "campaign-related" (or "non-exempt"). Exempt expenditures — costs of complying with the Campaign Finance Program, petition expenses, and certain expenditures for constituent services — are not subject to Campaign Finance Board spending limits. All other, non-exempt, campaign-related spending is subject to the Program's spending limits.

Expenditures are shown over three different periods. Expenditures made in the year prior to the elections (up to January 11, 1991) are shown in the columns labeled "CFB Limit 1990 (40,000)" and "Exempt 1990." For candidates in both the primary and general elections, expenditures reported as having been made after 1990 are shown by the date on which they were reported: those reported for the primary election, on or before September 18, 1991, appear in "CFB Limit 1991 PR (105,000)" and "Exempt 1991 PR," while those reported after that date, for the general election, are shown in "CFB Limit 1991 GE (105,000)" and "Exempt 1991 GE." For any candidate on the ballot in either the primary or general election only, all expenditures reported after 1990 are applied to the period for which the candidate was on the ballot, regardless of the date on which they were reported.

Campaign Finance Program limits applicable to each period for Council candidates are shown at the top of each column. In 1990, participating Council candidates were allowed to make a total of \$40,000 in campaign-related (or non-exempt) expenditures. During the 1991 primary and general elections, Council candidates were allowed to spend up to \$105,000 for each election.

Analytic Data

Chapters 2 and 3 present an empirical analysis of the 1991 Council elections using a variety of methodologies. **Regressions.** All regressions are based on the general linear model; a $|t|$ value of 2 or greater is considered significant. Data for all models are limited to candidates on the ballot in the general election. Contributions and spending represent total itemized contributions and expenditures, respectively, unless otherwise noted; no attempt is made to distinguish between contributions and spending for the primary and general elections. **Significance tests.** Wilcoxon rank sum tests are used to assess whether there are statistically significant differences between groups; all tests are conducted at the 95 percent level. **Comparisons by group.** In all group-level comparisons (e.g., contributions to winners and losers, spending differences between winners and losers), winners in the general election are defined as winners; all others (including candidates in primary) are defined as losers. **Vote spreads.** Vote spreads are defined as the percentage of votes in a district to the candidate of interest (e.g., winner or incumbent) less the percentage of votes to a given candidate from the same district; average spreads are the average of discrete percentage spreads.

For analytic purposes, districts are assigned to boroughs as follows:

Districts 8, 22, and 50 overlap more than one borough; data for these districts are included in Manhattan, Queens, and Staten Island, respectively.

NOTES

¹ Although Board of Elections disclosure forms are designed to record cumulative total contributions and spending, the data suggest that some candidates may have recorded financial activity separately for each election. In these instances, primary contributions and spending are not subtracted from the cumulative totals.

² In cases in which organization codes had not been or had been improperly assigned but the nature of the organization could be determined, Board staff corrected the organization codes.

³ Pedro Espada and Ernest Emmanuel, two participants who were ruled off the ballot, received \$25,355 and \$10,945, respectively, in public funds that are not reflected in this appendix.
