Dear Ms. Blair:

Attached please find the New York City Campaign Finance Board's (the "Board") final audit report for the 2005 election campaign of Dan Quart (the "Campaign"). This report is based on a comprehensive review of the Campaign's financial disclosure statements and submitted documentation. As noted in the Conclusions section of the attached report, the Campaign failed to adhere fully to certain Campaign Finance Program requirements.

Because the Campaign has not reported extinguishing all liabilities from the 2005 election, all other Program requirements, including contribution limits, remain in effect for activity related to that election. Please be advised that the Board may in the future require the Campaign to submit relevant information and proof of ongoing compliance with the 2005 election requirements. *See* Campaign Finance Board Rules 3-02(b) and 4-01(a).

As a result of actions taken by the Board, \$1,402 in penalties has been assessed against the Campaign which are delineated in the report and attached Board Determination letter. Checks should be made payable to the "New York City Election

Campaign Finance Fund." If the Board is not in receipt of the full \$1,402 by August 22, 2008, Dan Quart's name and the amount of unpaid penalties will be posted on the Board's Web site. The Board may also initiate a civil action to compel payment. In addition, the candidate and any principal committee he authorizes will not be eligible to receive public funds for a future election until the full amount is paid.

CAMPAIGN FINANCE BOARD FINAL AUDIT REPORT OF DAN QUART FOR CITY COUNCIL

BACKGROUND

The Campaign Finance Program (the "Program") was designed to limit the role and influence of private money in the political process. Candidates who voluntarily participate in the Program can qualify to have private contributions matched with public money. In exchange, the participants agree to full disclosure of their campaign finances, as well as to strict contribution and spending limits.

In December 2004, the City Council passed legislation expanding the jurisdiction of the Board to all candidates running for Mayor, Public Advocate, Comptroller, Borough President and City Council. Program participants and non-participants alike are required to disclose all campaign activity to the Board. In addition, all candidates must adhere to the contribution limits and the ban on corporate contributions. Non-participants are not eligible to receive public funds and are not subject to the expenditure limits.

REVIEW SCOPE AND OBJECTIVES

Board staff performed an audit of the financial disclosure statements and books and records submitted by the Campaign. The audit covered the information disclosed in the Campaign's financial disclosure statements six through seventeen covering the period from January 16, 2001 through January 11, 2006. The audit also included a review of the Campaign's bank statements covering the period November 20, 2001 through March 16, 2006.

The objectives of the Board's audit were ensure that (1) to the contribution and expenditure limits and prohibitions were adhered to; (2) financial transactions were accurately reported and documented; (3) adequate books and records were maintained by the Campaign to demonstrate compliance with the Campaign Finance Act and Campaign Finance Board Rules; and (4) the correct amount of public funds were received by the Campaign and was disbursed in accordance with the Act's requirements.

CONCLUSIONS

The Board staff's review revealed that the functions carried out by the Campaign were properly documented and that the applicable rules were followed with the exception of the following items:

- The Campaign exceeded the applicable \$150,000 expenditure limit for the primary election (see Finding #1). The Board assessed a \$1,302 penalty for this violation.
- The Campaign did not file the required daily disclosure statements during the two weeks preceding the 2005 primary election (see Finding #2). The Board assessed a \$100 penalty for these violations.

FINDINGS AND RECOMMENDATIONS

1. <u>EXPENDITURES – Exceeding the Legal Limit</u>

Program participants are limited in the amount of money they can spend on their campaigns. Expenditure limits curtail excessive campaign spending and level the playing field for candidates. An expenditure is considered to be made when the goods and services are received, used or rendered. Certain limited expenditures are exempt from the prescribed limits. *See* New York City Administrative Code §3-706, Rules 1-08(a), (b), and (d). A determination that the Campaign has violated the expenditure limit may result in a conclusion by the Board that the Campaign is not eligible for optional public financing. *See* Administrative Code §§3-703(1), 3-705(1).

The Board staff's review of the Campaign's disclosure statements and related bank statements found that the Campaign exceeded the 2005 primary expenditure limit by \$13,465.

Recommendation #1

The Campaign must respond by indicating why it failed to comply with the expenditure limit. If the Campaign disagrees with the calculation, it must provide an explanation along with documentation such as invoices, contracts and/or consultant agreements to support its argument. In addition, because the Campaign's exempt expenditure claims exceed 7.5%, or because the Campaign appears to have claimed exempt items that fall in non-exempt categories, the Campaign must document all of its exempt claims. In addition, for petition expenditures shown as not fully exempt (see

Exhibit Ia), the Campaign must provide a sworn affidavit from the candidate, treasurer, and any other consultant or employee who was responsible for the petitioning process, stating whether non-election activities, such as campaigning and/or literature distribution, were done in conjunction with petitioning.

Campaign's Response

The Campaign stated that it raised and spent money towards the 2003 election prior to passage of the local law which enabled incumbent office holders who were term limited in 2003 to run and serve in their respective offices until 2005. The Campaign stated that it continued to raise and spend money in connection with running in the 2003 race after the law was deemed impermissible. After the final court decision allowed incumbent officers run once again for their offices, the Quart Campaign concluded all expenditures in connection with the 2003 race. Therefore, the Campaign requested that the \$4,012 and another \$10,259 in expenditures toward the 2003 race be attributed to the 2003 Campaign and deducted from the 2005 Campaign expenditure limit.

The Campaign claimed \$27,082 as exempt expenditures for petitioning. The Campaign stated that it engaged in only gathering signatures during the petitioning period to get the candidate's name on the ballot and that the petition carriers were given only a single piece of campaign literature to provide the telephone number and web site of the Campaign to individuals who wanted to know more about the candidate. The Campaign provided two affidavits from the candidate and an affidavit from a Campaign worker stating that the Campaign did not engage in electioneering activities while gathering

petition signatures and requested that 95% of its petition expenditures be exempt from the expenditure limit calculation.

Board's Response

The Campaign stated that it was only given instructions on how to make the contributions collected for the 2003 race matchable in the 2005 race, by refunding the contributors for 2003 and have the same contributors re-issue their contributions for the 2005 race. The Campaign denied ever being given instruction on how their 2003 expenditures would affect the 2005 Campaign. Because the Campaign received benefit in the 2005 election from the contributions it missed between 2001 and 2003, the Board determined that the 2003 expenditures should be attributed to the 2005 election. However, the Board accepted 95% of the Campaign's petitioning expenditures as exempt. With this allocation the Campaign exceeded the 2005 election expenditure limit by \$1,302. The Board assessed a \$1,302 penalty for this violation.

2. <u>DAILY PRE-ELECTION DISCLOSURE – Statements of Contributions/Expenditures</u>

During the two weeks preceding an election, Program participants are required to report all contributions or loans accepted from a single source exceeding \$1,000, and expenditures made in excess of \$20,000, within 24 hours after they are accepted or made. *See* Rule 3-02(e).

The Campaign did not file the required daily disclosure statements to report the following contributions reported subsequently on its financial disclosure statements:

Recommendation #6

The Campaign must respond by indicating why the above findings do not constitute violations of Rule 3-02(e). The Campaign cannot file the daily pre-election disclosure statement now. If the Campaign has proof that it filed the required daily disclosure statement it should provide it now.

Campaign's Response

The Campaign did not respond to this finding.

Board's Response

The Board assessed a \$100 penalty for these violations.
