FINAL BOARD DETERMINATION - EC2013 CAMPAIGN

The New York City Campaign Finance Board ("Board"), at a meeting held on July 9, 2015, made the following final determination concerning the Jenifer Rajkumar 2013 Campaign (the "Campaign"):

The Board determined that the Campaign must return Public Funds as follows:

Type of Repayment ¹	Amount
1. Final Bank Balance	\$110.91
2. Qualified Expenditure Deficit	N/A
3. Overpayment of Public Funds Based on Valid Matching	
Claims	N/A

The Final Bank Balance amount of \$110.91 is the largest amount. Accordingly, the Committee and Candidate named above will be responsible for repaying \$110.91 in public funds.

You must pay to the Board the full amount due of \$110.91 no later than **June 6**, **2016**. Checks should be made payable to the "New York City Election Campaign Finance Fund," and mailed to the attention of Danica S. You, Associate Counsel, New York City Campaign Finance Board, 100 Church Street, 12th Floor, New York, NY 10007 or delivered to the offices of the Board.

If the Board is not in receipt of the full \$110.91 by **June 6, 2016,** the Candidate's name and the unpaid amount will be posted on the Board's Website and the Board may initiate a civil action against the Committee and the Candidate. In addition, you will be ineligible for public funds in any future election until this debt is paid in full.

You may challenge a public funds calculation in a petition for Board reconsideration within thirty days of the date of the Final Audit Report as set forth in Board Rule 5-02(a). However, the Board will not consider the petition unless the Campaign submits new information and/or documentation and shows good cause for its previous failure to provide this information or documentation.

You may also challenge this final determination, within four months, in the New York State Supreme Court pursuant to Article 78 of the Civil Practice Law and Rules.
