**FINAL BOARD DETERMINATION – EC2013 CAMPAIGN**

The New York City Campaign Finance Board (“Board”), at a meeting held on June 24, 2015, made the following final determination concerning the Teresa Scavo 2013 Campaign (“Campaign”):

The Board determined that the Candidate, the Treasurer, and the Committee named above violated the New York City Campaign Finance Act (“Act”) and Board Rules and are jointly and severally liable for paying \$900 in penalties as follows:

1. A penalty of \$575 for accepting two contributions over the limit. *See* Admin. Code §§ 3-702(8), 3-703(1)(f), (11); Board Rules 1-04(c)(1), (h), 1-07(c). The Campaign accepted a contribution over the contribution limit. After notification from Board staff, the Campaign refunded the overage promptly. The Campaign also accepted \$100 from the Candidate over the Candidate’s contribution limit, which it did not refund.

**Candidate ID Number: 1307-P**

2. A penalty of \$125 for accepting a contribution from a limited liability company. *See* N.Y.C. Charter § 1052(a)(13); Admin. Code §§ 3-702(8), 3-703(1)(l); Board Rules 1-04(c)(1), (e), (g), 1-05. The Campaign accepted a contribution from a limited liability company, and on notification from Board staff refunded the contribution promptly.

3. A penalty of \$200 for failing to document two transactions. *See* Admin. Code §§ 3-703(1)(d), (g), (11), (12), 3-715; Board Rules 1-09, 4-01(a), (c), (g), (k), 4-03. The Campaign failed to provide documentation of its translation of a palm card from English to Chinese. The Campaign also failed to provide wage records for three individuals connected with Get Out the Vote poll workers.

**The Board determined that the amount due is \$900.** On July 13, 2015, the Campaign paid \$900, the full amount due.

You may challenge this final determination, within four months, in the New York State Supreme Court pursuant to Article 78 of the Civil Practice Law and Rules.
