**HOW TO ADD A CANDIDATE PERSONAL POLITICAL CONTRIBUTION**

**CANDIDATE SERVICES TIP(S):**

- ✓ Contributions made by a candidate using his/her personal funds to a non-candidate political committee supporting or opposing candidates in New York City that total more than \$400 are considered campaign-related, must be reported to the CFB, count against the candidate’s contribution limit to his/her own campaign and against the committee’s spending limit, and may cause deductions to eligible public funds payments. See Chapter 3 of the [Handbook](#) for more information.
- ✓ Do not use this module to report [monetary](#) or [in-kind](#) contributions from the candidate to his/her own campaign. Those should be entered like all other contributions.

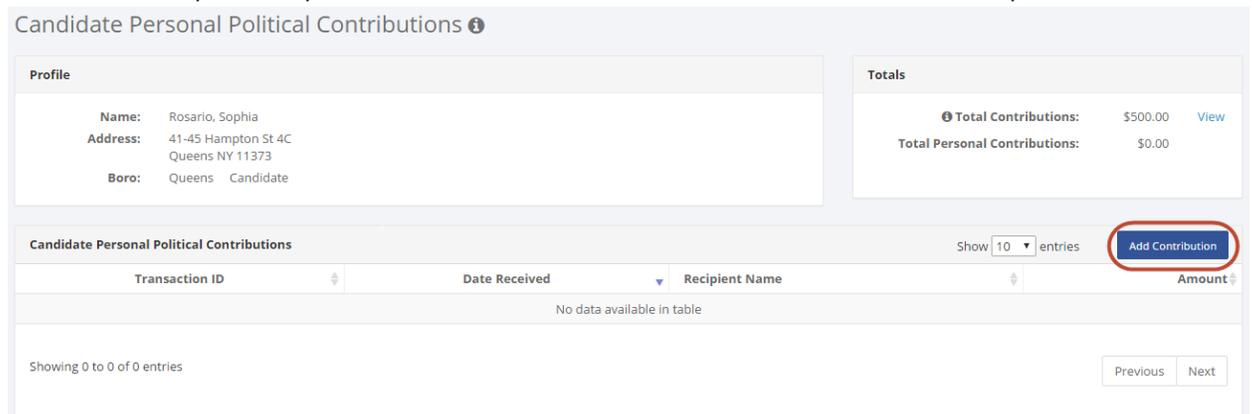
**1. Go to Candidate Personal Political Contributions.**

Click **Transactions** and then **Candidate Personal Political Contributions**.



**2. Click Add Contribution.**

You are now on the **Candidate Personal Political Contributions** screen. This page includes a Totals box with the aggregate amount of candidate personal political contributions and a list of each candidate personal political contribution. Click the **Add Contribution** button to proceed.



**3. Enter the details of the contribution and click Save.**

C-SMART will alert you if you leave out required information. Complete the fields as follows:

- **Recipient Name:** Select the recipient of the contribution from the drop-down list.
- **Contribution Date:** Enter the date on which the candidate made the contribution.

- **Amount:** Enter the amount of the contribution.
- **Notes:** Enter any additional notes related to this transaction.  
*Important: Information entered and saved in this field is intended for use by the campaign only and is not part of any data submitted to the Campaign Finance Board during any submission process.*

**1. Click the Transaction ID.**

From the **Candidate Personal Political Contributions** screen, click on the Transaction ID of the contribution you wish to edit.

### 1. Click the Transaction ID.
