Both monetary and in-kind contributions of goods and services are subject to these limits. All candidates are prohibited from accepting contributions from corporations, LLCs, and partnerships.</p>		
<p>* If an individual contributor has business dealings with the city at the time their contribution is made, these lower limits apply. Doing business contributions are not eligible for matching funds and do not count toward the threshold to receive public funds.</p>
