

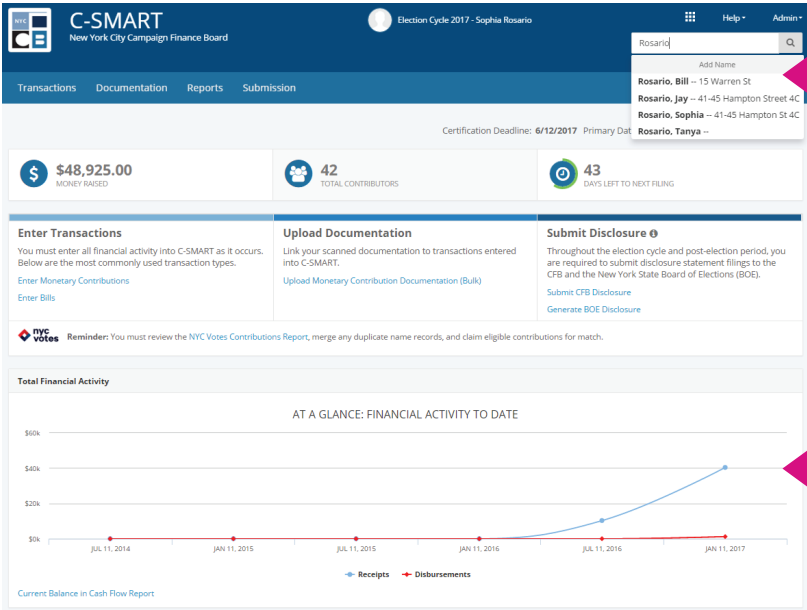


# INTRODUCING THE NEW C-SMART
