**AFFIRMATION**

I hereby affirm the following:

- I understand that expenditures for childcare services incurred before receiving approval from the Campaign Finance Board may not be paid for using campaign funds, and that to do so may subject my campaign to a violation/penalty.
- I understand that only expenditures for childcare services, such as daycare and babysitting, are eligible and that items, such as diapers and food, may not be paid for using campaign funds.
- I understand that only childcare services incurred before the election either during the year of the election or the year preceding the election may be paid for with campaign funds.
- I understand that, if I choose to participate in the Campaign Finance Program, aggregate childcare expenditures in excess of \$20,000 will count against my campaign’s applicable expenditure limit.
- I understand that public funds may not be used to pay for childcare services.
- I understand that (a) intentionally or knowingly making a false statement or intentionally or knowingly violating any provision of the New York City Campaign Finance Act is a Class A misdemeanor pursuant to §3-711(3) of the Act; (b) knowingly making a false written statement is a Class A misdemeanor pursuant to New York State Penal Law §210.45; and (c) knowingly offering false written information with the belief that it will become a part of the records of a public office and with the intent to defraud is a Class E felony pursuant to New York State Penal Law §175.35.
